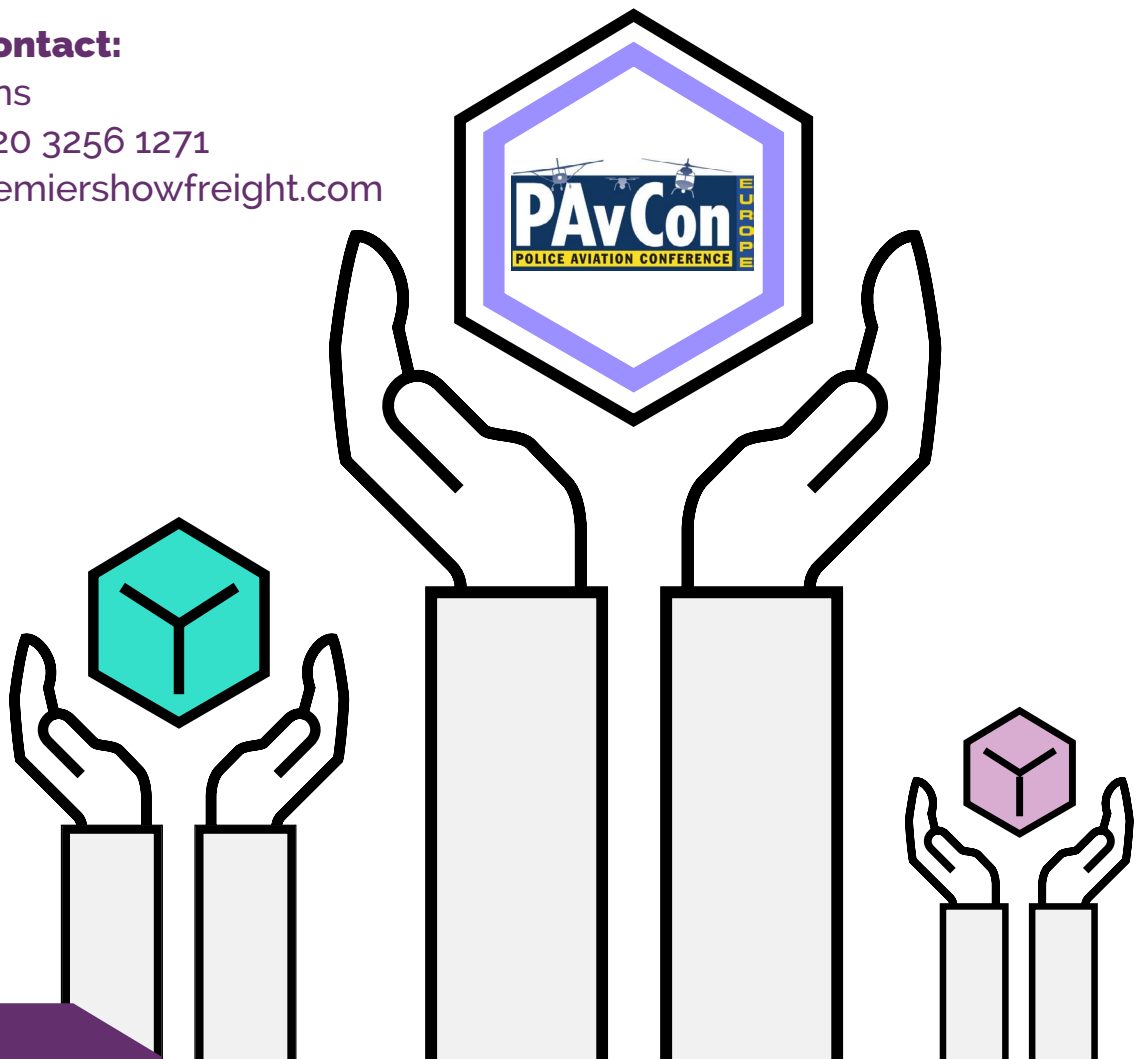

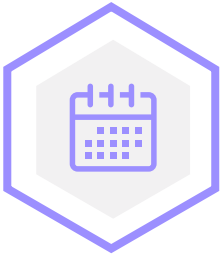

Basic 1 cbm = 250 kg chargeable weight.

### **1a. From free arrival advance warehouse facility ( via warehouse IML Vienna )**

Offloading and handling up to free delivered booth street level incl. intermediate storage / free accessible / no steps etc.

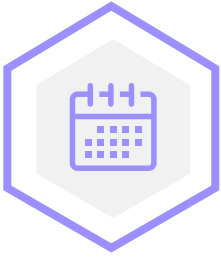

- Late arrival surcharge for shipment arriving after our deadline 25 %
- SVS fee ( Mandatory forwarding insurance ) as per list
- Documentation per shipment and way Euro 50,00
- Financing fee on total invoice amount 5 %
- Subsequent changes of the invoice each invoice Euro 25,00
- All prices are net + 20% VAT

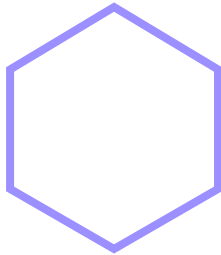

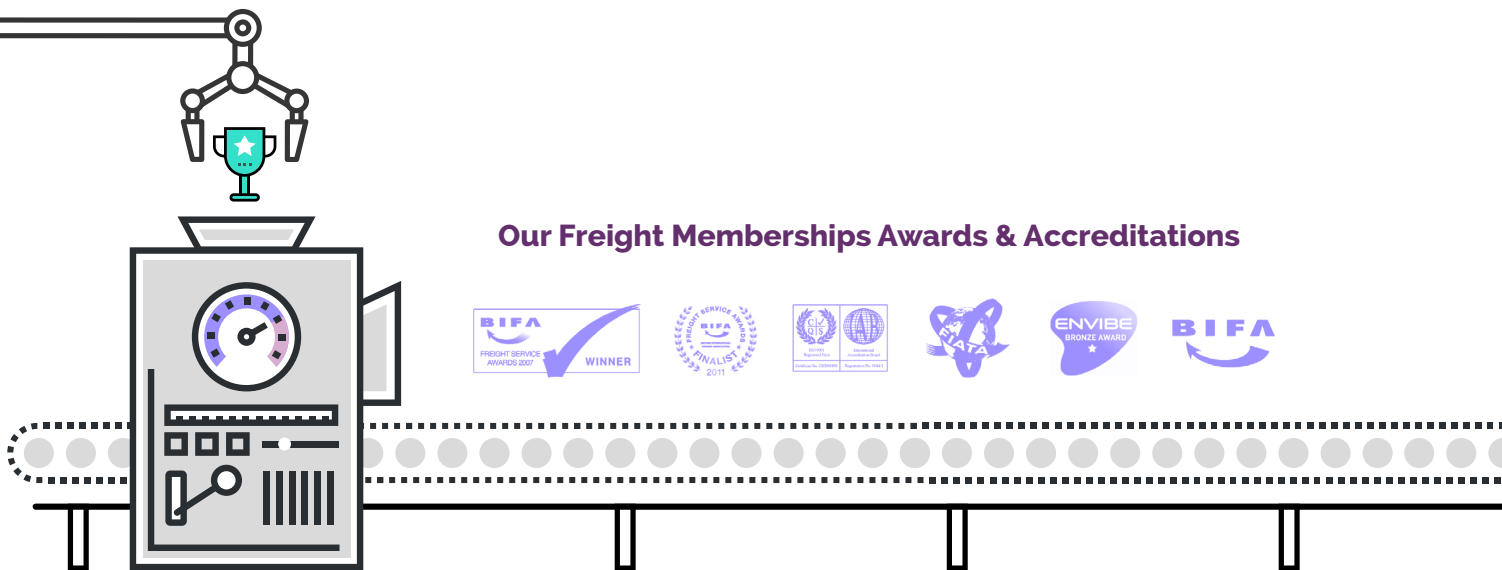
